ORDER

NO.F.12(10)/2000/F&S/P&C. In exercise of the powers conferred by sub clause (2) of section 3 of the Essential Commodities Act, 1955(10 of 1955) read with the Government of India, Ministry of Petroleum and Natural Gas Order notified under GSR No.519(E) dated the 5th June, 2000 and GSR No. 689(E) dated the 1st November, 2007, the Lt. Governor of National Capital Territory of Delhi hereby amends the Delhi Solvent, Raffinate and Slop (Acquisition, Sale, Storage and Prevention of use in Automobiles), Order 2002 as under:-

- 1 (1) This order may be called the Delhi Solvent, Raffinate and Slop (Acquisition, Sale, Storage and Prevention of use in Automobiles) (Amendment) Order, 2008.
- (2) It shall come into force on the date of its publication in the Delhi Gazette.

2. In the Delhi Solvent, Raffinate and Slop (Acquisition, Sale, Storage and Prevention of use in Automobiles) Order, 2002, after Form A, the following Schedule shall be added, namely:-
