
**ORDER**

Directions have been issued by Hon'ble Delhi High Court vide Order dated 28.05.2020 in the matter of W.P (C) 2161/2017, Delhi Rozi-Roti Adhikar Abhiyan Vs Union of India and others, wherein the Hon'ble High Court has directed that all the ration shops will remain open seven days a week to cater to the demands of the ration card holders and Food Inspectors of each district shall conduct regular inspections of the shops to ensure that they are operating strictly in terms of the directions issued by the Court and the Department.

Accordingly, it is directed that Food Supply Inspectors shall conduct regular inspections of the Fair Price Shops under their jurisdictions and shall ensure that FPSs operate strictly in terms of directions by Hon'ble High Court and the directions issued by the Department vide Order F.No.15(41)/CFS/Dist/2020/859-71 dated 26.03.2020, Order F.No.15 (46)/FSO/Dist/2020/PMGKAY/1198-1211 dated 23.04.2020 and Order F.No. F.No.15 (46)/FSO/Dist/2020/PMGKAY/824-36 dated 31.05.2020 issued during distribution cycle of respective months.


All Zonal ACs and Circle FSOs shall personally ensure compliance of the above direction and monitor. The Report on such inspections shall be submitted to Enforcement Branch HQ, on [acenf.fs@gmail.com](mailto:acenf.fs@gmail.com) by Zonal ACs for their district fortnightly.

Further, all the Zonal ACs are requested to provide information regarding Enforcement activities carried out in their District during last two weeks. This information should be submitted positively by 11 AM on 06.06.2020.
