Subject:- Shortages on account of retail sale of rationed articles.

The representation of Delhi Sarkari Ration Dealers Sangh regarding allowing admissible shortage claimed by FPS holder on account of retail sale of specified food articles i.e. wheat, rice & sugar to the beneficiaries have been considered by the department during the course of financial implication assessed on enhancement of margin money.

The Fair Price Shop holders are informed that shortages not exceeding the scale mentioned against each of the following specified food articles would be permissible on the retail sale of such articles under Targeted Public Distribution System:-

| <u>Name of the Specified Food articles</u> | <u>Shortage to be allowed on the sale of 100 kgs.</u> |
|--|---|
| (a) Wheat | 500 grams. |
| (b) Rice | 500 grams. |
| (c) Sugar | 1000 grams. |

These scales will operate as limits upto which shortages in stocks would be allowed to Fair Price Shop holders at the time of stock taking on inspection only.
